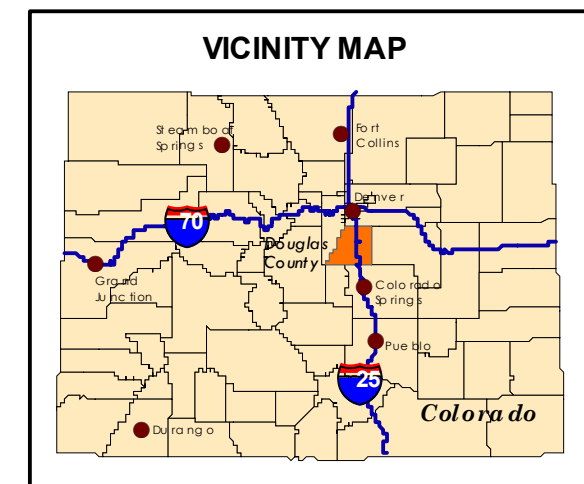

All platted subdivisions, with housing units in water and sanitation district service areas or mutual water company service areas, were assumed to be served by public water providers. All unincorporated areas with housing units in a service area were assumed to be served by domestic wells. All properties with housing units, located outside water and sanitation districts or mutual water companies service areas, were assumed to be served by domestic wells.
