# MINUTES OF THE REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE RURAL WATER AUTHORITY OF DOUGLAS COUNTY HELD

June 21, 2017

A regular meeting of the Board of Directors of the Rural Water Authority of Douglas County (RWADC) was held on June 21, 2017, at the Douglas County Miller Building, 100 Third St., Castle Rock.

| Officer Reports         | Vice Chairman Director Bucknam reported that dissolved manganese   |

above the action threshold has been found in the homeowner dual

aquifer well, Dawson test well and pit of Chambers Reservoir, but the previously discovered iron at the threshold concentration has subsided in the reservoir and all wells. High rate of Reservoir pumping caused the leakage into the reservoir to exceed the limits of the liner design. The west reservoir wall continues to slough off the side of the reservoir.

Secretary Withers had no report.

<u>Treasurer</u> The Board was provided the list of Claims and Financial Statements for the period ending June 21, 2017. There was one claim presented: \$1,155.77 from Colorado Circuit Rider, LLC for professional staff services.

The June 21, 2017, Schedule of Cash Position showed a General Fund Balance of \$39,207.84, after paying the June claim. The May31, 2017 bank reconciliation was reviewed.

The Treasurer's Report was accepted and the claim paid with a **motion (Kennedy/Giclas),** which passed by a vote of 4-0.

Well owners at the Biennial meeting were quite interested in a workshop or presentation on "Well Drilling." Director Kennedy will call Lloyd Nolan, Chief Inspector at the Colorado Division of Water Resources, to see if he might come speak or refer someone who will do a good job. ### **CWCB Well-Monitoring Program**

Director Bucknam will contact Rhett from USGS about costs for speaking on an update to the known water levels from the Well Monitoring Program. The public would be invited at a cost to break even for 50 attendees.
